

Dear Board, District and Sub-branch members

The Returned and Services League (RSL) Queensland has a proud history of serving Queensland's veteran community over the past 109 years. It would be a privilege to join the Board to assist in setting the future direction of support for veterans in our state.

I am currently Commander of the Army's 8th Brigade; Chairman of the Board and part owner of Protegas Australia (a veteran owned Intelligence Professional Services company which employs 26 veterans – over 75% of the workforce); and Patron of Young Diggers (a not-for-profit organisation providing assistance dogs to veterans and first responders).

My military story started 30 years ago when I entered the Australian Defence Force Academy and then spent 12 months at the Royal Military College – Duntroon. As a Lieutenant, I was posted to 110 Signal Squadron, deployed on Operation GOLD (Sydney Olympics) and undertook language training at the Defence Force School of Languages, where I studied Indonesian and French. As a Captain, I was employed in the Headquarters 1st Division, deployed to East Timor as the lead intelligence officer of the Australian National Command Element, and was an analyst at the Defence Intelligence Organisation (DIO). I also filled the roles of Staff Officer to Director DIO and Aide-de-Camp to Commander 2nd Division. In 2006, I deployed to Afghanistan and established the Australian presence in the Regional Command South Headquarters' Kandahar Intelligence Fusion Centre.

As a Major, I was posted the United States' (US) Pacific Command's Joint Intelligence Operations Centre where I led an Intelligence team focused on Southeast Asia. When I returned to Australia I attended the Australian Command and Staff College. I then moved my family to Southeast Queensland for a posting to the Defence Intelligence Training Centre where I commanded the Army Intelligence Training Wing. Upon promotion to Lieutenant Colonel, I deployed as a senior intelligence analyst in the International Security Assistance Force Joint Command (IJC), Afghanistan. In 2015 and 2016, I commanded the Defence Force School of Intelligence, was the Deputy Head of the Australian Intelligence Corps and held seats on the National Intelligence Community Training Committee and the Defence Human Intelligence Committee. In 2017, I posted to the US Command and General Staff College as the Australian Army instructor and the Senior Australian Defence Force (ADF) representative in Kansas.

Upon return to Australia, I was promoted and served as the Commandant Land Warfare Centre (LWC) and the Senior Australian Defence Force (ADF) Officer at Kokoda Barracks. I led the ADF support to the Sarabah and Lower Beechmont bushfires in 2019, and Kokoda Barracks' response to COVID-19 whilst in that role. I subsequently transferred to the Army Reserve in 2021 and filled the role of Assistant Commander 11th Brigade, responsible for training and force modernisation. I was promoted to my current rank and appointed as Commander 8th Brigade in December 2022. In this role I hold a seat on the Army's Training Committee.

I have been a member of the Tamborine Mountain RSL sub-branch for at least the last two years and whilst I have not filled an appointment in the sub-branch, I have actively supported the sub branch with finding guest speakers for commemorative events and gaining clarity on contentious issues for members. I have also actively supported ANZAC Day ceremonies as either the Reviewing Officer or Guest Speaker at Tamborine Mountain, Canungra,

Beaudesert, Upper Coomera, Mudgeeraba, and Southport, regularly speaking at two or three ceremonies on ANZAC Day.

My interest in pursuing a role on the Board has emanated from a desire to continue to support veterans beyond service in the Army. I consider my leadership responsibilities for current and former service members does not stop when I take off my uniform. I have also discussed the potential to fill the Vice President position with Major General Stephen Day and Mr Nick Gould in order to understand the commitment required and to ascertain if they would be supportive and would recommend that I nominate for such a role.

As Vice President, I would aim to support the President in achieving his vision for RSL QLD, whilst bringing Part-Time and Full Time Defence experience and perspectives into the Board room. Further, I aim to assist shaping the strategy for veteran support over the next three to five years.

From a personal perspective, I am aiming to gain a better understanding of services available to support veterans that may assist me in my leadership roles in business, as Commander 8th Brigade and as Patron of Young Diggers. I would also value the opportunity to be part of a high calibre board responsible for making significant decisions for the veteran community in Queensland.

I look forward to potentially serving on the RSL QLD Board and serving the Queensland veteran community.
