A 2 tour Vietnam Veteran with 34 years in the police service I retired in 2006.

I enhanced my communication skills in the police service, growing in knowledge and experience through dealing with many diverse situations involving public facing matters. I also developed the organisational and leadership ability to implement many projects including setting up and managing the State Central Exhibit and promoting and managing the State Co-ordinator for Neighbourhood, School, and Marine Watch.

I was heavily involved in the leadership, organisation, promotion, and fundraising for Defence Force Trackers and War Dogs Association. Networking and promotion were vital to the establishment of the association in its effort to support Dog Handler and their Dog Teams, including various public speaking and Memorial Day organisation.

In 2011 I transferred my RSL membership to Woodford where I commenced my immersion in all aspects RSL. A returned veteran, I embrace and support the aims and commitments to the League.

Since those first tentative steps in Woodford Subbranch I have become an experienced Welfare and Advocacy Officer. I have researched and embraced the "Live LIFE Alarms" Program to assist members with balance difficulties. I am dedicated to improving Sub Branch staff knowledge and understanding of RSL Policies and Procedures, providing training and sharing of ideas and new developments.

To cover Welfare deficiency within the District I introduced a mobile team that covers Hospital visits and assistance wherever necessary and in emergency situations should they arise---very handy during this Covid19 Pandemic. RSL Queensland supports this initiative with a view to rollout across the State.

I have been invited to join the Sunshine Coast Disaster Management and Emergency Committee with a view to identifying the stressful situations arising from these events, formulating contingencies to alleviate and support adverse effects.

STATEMENT BY JOHN STRACHAN OAM NOMINEE FOR STATE DEPUTY PRESIDENT RSL (QUEENSLAND BRANCH)

Fellow Members,

Given the impositions of the Covid Pandemic which has already changed the RSL landscape to the extent that when it is finished we don't know what the new normal will look like, we should be wary of changes imposed as a result. This is a "Grass Roots" organisation where members should be making the major decisions affecting the organisation and change should be for the better otherwise we will lose our identity and purpose. Winston Churchill once said that if we don't know where we have come from we can't know where we are going. Everything old is not bad and everything new is not good; there should be a happy balance in what we do.

Whilst the State Executive and the Board were elected to conduct and shape the business of the League between AGMs, we are also there to preserve the ideals and dignity of the organisation in to the future. A good working knowledge of the RSL and its iconic status in the community is an essential in this position and I have developed this as a recent Sub Branch President and former District President. In fact, this experience provides an insight into the challenges facing us at this level and does provide awareness of what is required to take us forward. What must be at the forefront of all our thinking and actions however is our ability to adhere to the furtherance of our objects and assist Veterans wherever they maybe. In short we should never lose sight of the purpose and function of the RSL, it is our reason for being as an organisation.

All the high profile programs - the Employment, Homelessness, Education etc - are very worthwhile and necessary, but should be enhancements to the real work of the RSL, the work done at Sub Branch level be it mates looking after mates, taking a fellow Veteran shopping, mowing his/her lawn etc and providing the camaraderie most us are seeking. Whilst we should be embracing the younger veterans and encouraging them to join, we cannot forget about the 30,000 other members, us!

To do all this we must retain our sense of purpose, keep the ship on a straight course, prevent it from becoming top heavy and above all keep it sailing in the right direction. Your Board must adhere to these ideals be forthright and firm in their deliberations and represent you the Membership in an unselfish manner without thought of personal gain, after all that that is what you elected them for, and I believe you must hold us to account if we are to remain a Membership based organisation.

We are an iconic organisation and we **must** maintain and further this image. All the above may sound like rambling, but at this juncture you may need to read between the lines.

The RSL exists to benefit Members. It seems at the moment as if it exists to only raise funds to sustain itself as a business and the Membership is simply a reason for being. This could render Members irrelevant further down the track.

The ACNC were very definite on how funds raised should be spent. As a result of Covid and other factors we have Sub Branches struggling to keep their heads above water with all sorts of pressures both financial and governance wise. It is not tomorrow's problem - it is today's and needs to be addressed **now**, not after a myriad of studies by outside agencies using Veterans' funds. Another now problem is Membership which needs to be urgently addressed. Members have over the years vehemently resisted any watering down of eligibility to become a member and we should not start now! In short, an individual must have worn the uniform of the Defence Force to join the League and unless they have served they are not eligible. The last figures available indicated that there were well over six figures of ex servicemen and women in Queensland who are not members of the RSL and we need to pursue that cohort to become Members. We should not go down the same track as other States with affiliates; that to me is a recipe for disaster and problems in the other States are evidencing this. In one state, non-League Members can sit on Sub Branch boards. The other answer is to recognise non-renewals and put measures in place to fix the issue. We have a very large population of current serving servicemen and women who are posted regularly, many whom we lose as members. We could address this by the formation of an Electronic Sub Branch which is portable wherever they are posted, and when they discharge they can transfer to the Sub Branch of their choice. All that is required is a regular newsletter contact etc providing updates on programs on pertinent items of interest.

These are not answers for all our shortcomings but merely a snapshot of what can be done if there is a will.

Where we should acknowledge the work being done is that of Veteran Services who are doing great work in that space supporting our members and future members. Success is not final and failure is not fatal, it is the courage to continue that counts.

There are many challenges facing us if we want to remain for another 104 years, but to remain with our same sense of purpose and unity in a form that cares for members is the real challenge.

It is, as always, a privilege and honour to serve the ex-service community, and I firmly believe my expertise and experience have allowed me to assist in driving change and with your support I can continue in the next term and help restore the RSL to its rightful place as the premier ESO.
