# **TALENT RELEASE DETAILS**

### Why are we collecting your personal information?

The Returned and Services League of Australia (Queensland Branch) ABN 79 902 601 713 (**RSL Queensland, us or we**) collects personal information to explain and promote RSL Queensland's programs, services, events and activities (the **purpose**). We are seeking your consent to collect, use and disclose your personal information for the purpose.

### What personal information will be collected?

We are seeking your consent to collect, use and disclose:

- your photograph
- a digital recording, audio recording or video recording of you
- information to describe your image, such as your gender, age, features or clothing worn
- information about your experience with our programs, services, events or activities
- other personal information such as your name and the city you live in.

## How will your personal information be used?

We may use your personal information (including, if you consent, your name and where you are from) (the **media**) in any of the following:

- printed publications such as brochures, booklets, fact sheets, newsletters, magazines and reports
- display banners and posters
- television, radio and newspaper advertisements and other media
- internet pages (such as our websites <u>rslqld.org</u> and <u>rslartunion.com.au</u> and/or RSL Queensland social media pages).

We may also share the media with affiliated organisations which share similar objects, such as:

# Privacy information

We are collecting the information contained in this consent form to verify the consent for use of your personal information for the purpose.

RSL Queensland is required to comply with the Privacy Act 1988 (Cth) in relation to the collection, use, storage, security, and disclosure of personal information.

#### Modification or withdrawal of consent

When giving your consent you should be aware that any information published on websites and social media will be accessible to people worldwide, that the information will be indexed by search engines and that the information may be copied and used by any web user.
