Why are we collecting your personal information?

The Returned and Services League of Australia (Queensland Branch) ABN 79 902 601 713 (**RSL Queensland, us or we**) collects personal information to explain and promote RSL Queensland's programs, services, events and activities (the **purpose**). We are seeking your consent to collect, use and disclose your personal information for the purpose. This is optional, and you do **not** have to provide your consent.

What personal information will be collected?
